Pursuant to the December 20, 2024, Minute Order [Dkt. No. 22], Plaintiff Hong Kong Yu'En E-Commerce Co. Ltd. ("Plaintiff"), hereby submits the following Status Report of service of process, settlement discussions, and any further information that plaintiff wishes to bring to the Court's attention. Plaintiff has served all Defendants whose information was provided by the Amazon Platform on January 3, 2025. The Court granted a Preliminary Injunction on January 22, 2025, [Docket 35]. Defendants have until January 27, 2025, to file an answer or responsive pleading with the Court.

Of the seventeen (17) Schedule A Defendants, Plaintiff has engaged in settlement discussions with sixteen (16) of the named Defendants and intends on filing a notice of voluntary dismissal for ten (10) of them on or about February 1, 2025.

At the time of this filing, no Defendants have answered or filed a responsive pleading. Plaintiff intends to file a Motion for Entry of Clerk's Default, excluding any Defendant who

resolved their claims and Plaintiff will continue to work with those other Defendants who are engaged in settlement discussions.
